

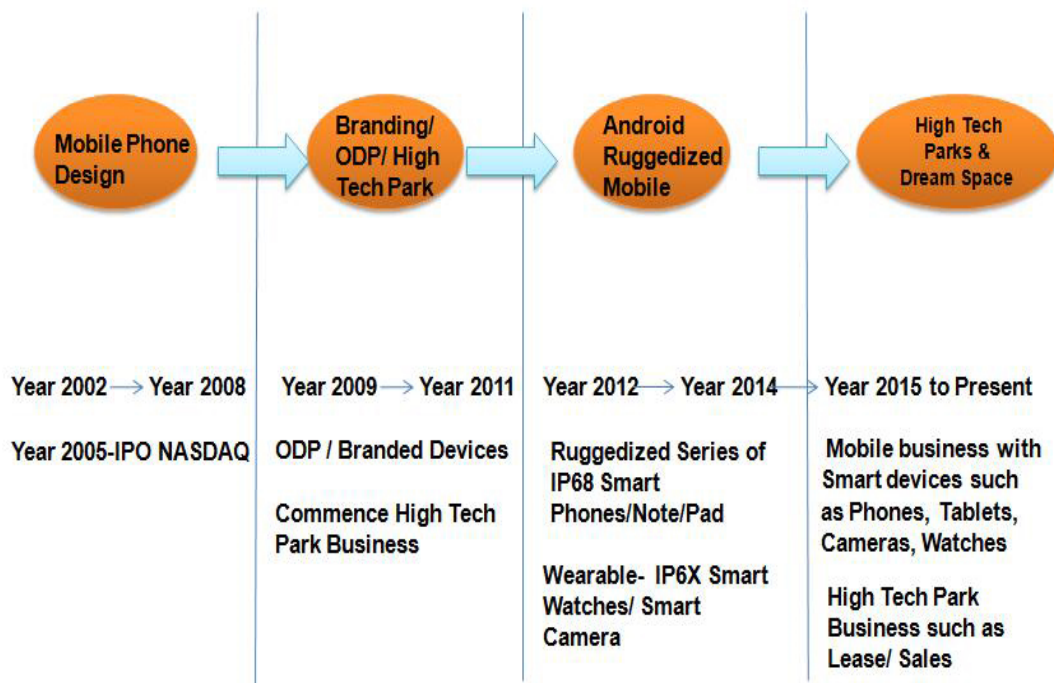
**Corporate Profile**
